Letter of Ownership and Authority

The Entertainment Software Association (hereinafter referred to as "ESA"), having its principal place of business at 601 Massachusetts Ave., NW, Suite 300, West Tower, Washington, DC 20001, states as follows:

1. ESA is the trade association for the video game industry in the United States;
2. ESA has been authorized by its Members¹ to take actions consistent with applicable laws to enforce their intellectual property rights in such titles when infringing copies are discovered on websites, including by delegating that enforcement authority to service providers on an "as needed" basis;
3. Pursuant to the authority conveyed by ESA Members via ESA's Articles of Association and the terms of agreements, ESA hereby authorizes WebKontrol Inc., registered address: 838 6 Avenue 6th Floor, New York 10001, NY, United States, represented by its Director General, Valigourskaia Olia (hereinafter referred to as "WebKontrol"), to:

3.1. Submit notices to websites ("Sites") including:

- 3.1.1. Websites that host, link to, and/or intentionally direct members of the public to unauthorized copies of video game titles identified in Exhibit A, attached hereto (or as superseded by subsequent versions of Exhibit A that may be transmitted by ESA to WebKontrol), and/or which identify URLs that lead to unauthorized copies of game titles identified in Exhibit A;
- 3.1.2. Marketplace websites that offer and/or sell products or services that are marketed and/or used to circumvent technological protection measures to prevent the unauthorized copying, access, distribution and/or use of their games, including those identified in Exhibit A;
- 3.1.3. Groups on vkontakte upon which WebKontrol discovers unauthorized use, sale or distribution of ESA Members' copyrights and trademarks in connection with unauthorized sales of ESA Members' in-game digital items or digital account credentials;

3.2. Engage in correspondence with the administrators and operators of Sites to ensure that infringing content is removed and/or the Sites are closed down; and

3.3. Engage in correspondence with third parties involved in the provision of services that facilitate the Sites'



operation to secure the third parties' assistance in securing the removal of infringing content from or the closure of the Sites.

4. ESA Members own and/or hold the copyrights in the video game titles identified in Exhibit A, attached hereto (or as superseded by subsequent versions of Exhibit A that may be transmitted by ESA to WebKontrol pursuant to the terms of the agreement between ESA and WebKontrol).

This Letter of Ownership and Authority is valid from the date of this letter until March 31st, 2021, without the right of sub-delegation, unless the agreement between ESA and WebKontrol terminates prior to that date, or the authorization described herein is withdrawn or amended in writing (including email) by ESA prior to that date.
